Policy Approval Process: Policies developed for or by the Board of Governors must initially be submitted to the Governance Committee, which will then consider the policy or redirect it to the appropriate committee; if redirected, the policy afterwards will return to the Governance Committee for consideration. Only upon the recommendation of the Governance Committee will the policy be forwarded to the Board of Governors for consideration and approval. **CARRIED**.
